



Suspension or Deferment Form

This form is to be completed by students who request for suspend or defer your course due to compassionate and compelling circumstances. If your request is refused, your enrolment at SPI remains active and you are expected to continue attending your classes as usual. Please ensure that this form must be read in conjunction with Deferral, Suspension and Cancellation policy. Before completing this form, Student is advised to consult the SPI student services. An International student is also advised to consult DHA to understand how suspension or deferment may impact your visa.

This form will not be accepted without supporting evidence.

Section 1: Definitions

- **Suspension** means the temporary postponement of enrolment during the course, the duration of suspension can be granted for **up to 6 months** (e.g. due to compassionate or compelling circumstances accompanied by supporting documents).
- **Deferral** means the postponement of study requested by students prior to the commencement of the course; the duration of deferral can be granted for **up to one year** (e.g. due to compassionate or compelling circumstances accompanied by supporting documents).

5. My enrolment may be cancelled if I failed to resume studies within two weeks after the suspension date.
6. My enrolment may be cancelled if I provide false or misleading information with regards to my deferral/suspension.
7. I understand that I have to withdraw my enrolment if my suspension or deferral (and subsequent extension) is more than 1 year.
8. I must leave Australia if my suspension is for more than 28 days unless unfit to travel as evidenced by a doctor's certificate.
9. I am aware that withdrawing after deferment and suspension may impact my eligibility for a refund.
10. I have read SPI's *Student Deferral, Suspension and Cancellation Policy* and understand that the changes to my enrolment may result in a change of CoE or the status of my student visa.
11. I acknowledge and agree that SPI would use my information where necessary based on SPI's *Record and Information Management Policy*.
